

My researcher career started in the early 1990s. From the beginning, I have been inspired by the social constructionist theory. Born and educated in Turku, Finland, I moved in 1989 to the then-Soviet Republic of Estonia (independent from 1991), and worked within an emerging alternative, independent institution of higher education – from 1997 as Professor of Sociology at the Estonian Institute of Humanities; in 1998-2001 as the institute's Rector (principal); and in 2005-2008 as the Director of its Centre for Civil Society Studies and Development. In 2005, the institute merged with Tallinn University. I also served three terms as the President of the Estonian Sociological Association (1998-2003). Much of my scientific work is related to the development of civil society in Estonia and more generally, in Central and Eastern Europe. From 2006, I am Professor and Chair of the Sociological Unit of the Åbo Akademi University, Finland's Swedish-speaking university located in Turku. The courses I currently teach include Methodology of Social Sciences, Sociology of Knowledge, Qualitative Research Methods, and Sociology of Organizations. My current research interests are rather broad, including Science and Technology Studies; studies in ethnic minorities; social theory; methods; and sociology of culture and the Arts.
